- **Multipliers and Ogden 6**

Allan Gore QC will outline the changes introduced by Ogden 6, discussing the impact this has on Multipliers and the calculation of damages. His expertise in the PI area is recognised in Chambers and Partners 2006 where he is described as “a fearless advocate, with a sharp legal brain” and “extremely able tactically and very assertive”.

- **Industrial Disease - Rothwell**

Harry Steinberg was junior counsel instructed on behalf of the claimants throughout this long running litigation. Harry will provide an overview of the asbestos-related pleural plaques arguments in the House of Lords and will highlight the potential outcomes of this litigation for both claimants and defendants.

- **Employment Law for PI Lawyers - Deadman**

Andrew Hogarth QC appeared for the defendant in Deadman. In this decision the Court of Appeal make it clear that a claimant will not often have a better chance of success in a stress at work claim by putting the claim forward as a breach of contract rather than as a breach of the duty of care. Andrew is recommended as a top employment and PI silk in the legal directories and in this session he will provide PI lawyers with an understanding of the parts of employment law which affect PI claims.
