- Drafted a defence in a claim against the police by an officer who allegedly sustained psychological symptoms after potentially acquiring HIV and hepatitis C during an arrest.
- Acted for a claimant with a complex chronic pain syndrome following an accident at work.
- Successfully defended a company against a claim by an employee who claimed to have fallen off the back of a lorry.
- Acted as a junior in a quantum claim in excess of £4 million concerning a brain injury and other physical injuries preventing the claimant working as a fund manager in the city.
