Charter Hi v Minister of Transport (155/10) [2011] SCA 89 – Represented the appellant in an appeal arising from the crash of a Beechcraft C90 during an instrument flight renewal test undertaking in the Cape Town general flying area.

ZS-SVN Syndicate v 43 Air School (Pty) Ltd and another 2007(6) SA 389 (E) – Appeared on behalf of the insurers of an airport in a subrogation action by aircraft owners arising from the aircraft landing on a closed runway.
